

Reviewed report - see attached. Below are highlights

- Eight out of twelve positions filled as of May 31 2021. The first meeting of the 2021/22 school year was held August 31, 2021.
- Council settled on 3 goals
  - o 20 volunteers hours for the year
  - o Increase attendance to 20 parents in attendance
  - o Create a communications plan
- Year started with welcome back chalk art in September.
- Kindergarten hot chocolate and stuffy meeting held on September 29th so parents could meet and students could spend time meeting. Brought back Halloween monster mash dance, DJ Drummond brought the tunes!
- Senior secret service to deliver holiday gifts to seniors
- Gift baskets to staff for holiday
- 4 Kahoot nights
- Food drive April 4 and 14th, collected 800LBs of food
- Fun lunch came back! We started in December. Special snack for kindergarten started up in November 2021 and has been ongoing
- Teacher appreciation and bus driver appreciation saw gift cards, and breakfast and lunch plus a small gift in May.
- Students earned over 90% on math-a-thon and won a ton of fun things such as extra recess and no homework certificate
- Last event is Highwood pool swim end of June
- Fundraisers were Davison Orchards, sweater fundraiser, opt in raised \$1300.00, sold 33 ginch trees making \$330, \$921 for Magic show. Math-a-thon raised \$7615.00
- Contributed to ASC community fund to fund grad walk. We also covered the cost of a 1 act play, and bridging activities with NE and NW campus students meet up.
- Gave \$5000 for teacher discretionary fund for classroom items. Grade 4's were given \$100 to do the 12 days of giving campaign. Funded a wellness package for staff during a PD day. Funded some money for earth day community clean up. Funded grade 4 graduation grad and busing for Calaway park event.
- ASC adopted 4 motions this year
- Heritage committee was staffed by FFCA staff to focus on diversity and inclusion. Orange shirt day was celebrated as
  parat of the National Reconciliation Day. We also celebrated a number of key holidays observed by different cultures.
   This included parent volunteers visiting or sharing their customs with all students.
- AGM attendance is at 15 tonight, 5 away from our 2022 goal.

# 2021/2022 Annual Report

This was another exceptional year due to the evolving provincial COVID-19 Response. Significant COVID-19 restrictions were lifted on March 1<sup>st</sup> 2022 and School Council is slowly adapting to the relaxation of restrictions and reintroducing in-person activities to the school community.

The 2021 School Council – Northwest Elementary Campus Annual General Meeting was held virtually on May 31<sup>st</sup>, 2021. Eight out of twelve open positions were filled at the meeting leaving the Community Service Coordinator, Kindergarten Representative / ECS Special Snack Coordinator, Advocacy Committee Chair, and Heritage Celebration Committee Chair positions unfilled.

The first meeting of the 2021/2022 Council was held on August 31<sup>st</sup>, 2021 and Council met 7 times after that on September 21st, October 19th, December 8th,, February 8th, April 7th, April 26th, and May 24th.

Thankfully, volunteers stepped up to fill the Community Service Coordinator and Kindergarten Representative / ECS Special Snack Coordinator positions.

The Advocacy Committee Chair and Heritage Committee Chair positions remained vacant the entire term. Thankfully, staff took on the work of celebrating the diversity of heritage among our community.

### GOALS

The following goals were eventually settled upon:

School Council funded \$290 worth of bean bags, saucer cones and holding rack, utility balls, rhino skin balls, and skipping ropes to be used for DPA.

### The Association of FFCA School Council (ASC) Contributions

Every year, Council provides funding to ASC so that the Councils of all of FFCA's campuses can meet, exchange ideas, and work on school-wide initiatives. This year, ASC has continued planning FFCA's 25<sup>th</sup> Anniversary Event to be held at Heritage Park on Saturday June 4<sup>th</sup>, 2022. ASC also ran a school wide Food Bank Drive in April. This year, Council contributed \$1,700 to ASC, which includes \$1,500 to fund multi-campus activities through the Community Fund.

ASC approved the following Community Fund applications late in the year once restrictions were lifted:

- Grad Walk
- 1 Act Play North/South Partnership
- Bridging Activity Bussing costs for SWE Grade 4 students to visit SMS
- Bridging Activity Bussing costs for NEE and NWE Grade 4 students to visit NMS
- Bridging Activity Bussing costs for NWE Grade 4 students to visit the NEE for team building

ASC continues to pay for the membership fees of all FFCA School Councils to be a part of The Alberta School Councils' Association (ASCA), an organization that states that "We represent parents on school council to engage with Alberta's Education Ministry.".

#### **Teacher Discretionary Fund**

School Council made available \$900 per grade level and \$500 for specialty teachers to spend at their discretion on rewards for in-class challenges, books, and other extras for students.

#### 12 Days of Giving

Council provided \$100 for the Grade 4s for wrapping paper and little gifts to give to students in the other grades.

### **Gift Baskets**

Council gave gift baskets to staff during the holiday season.

# Wellness Package

Council provided \$208 towards a wellness package for the February PD day.



# Earth Day Clean-Up

Council funded garbage bags and gloves for an Earth Day community cleanup in April.

# COMMITTEES

### **Advocacy Committee**

School Council did not fill any positions in this committee, however, Vice-Chair Andrew Chu was appointed to be Council's voting delegate at the Alberta School Councils' Association Annual General Meeting on April 24th. New Horizons Charter School designated our Council to be its voting proxy at the AGM.

The following Advocacy Policy resolutions were adopted at the AGM:

- 1. That Alberta Education and Alberta Transportation collaborate to develop universally recognized signage and make this signage, and other appropriate steps, available to school boards to be placed at higher risk bus stops.
- 2. That the Minister of Education extends the weighting of Diploma Exams at 10% while children's education is being affected by significant learning disruption.
- 3. That the Minister of Education Conduct a policy review of the current infrastructure maintenance funding formula to: a) address the large, deferred maintenance problem facing Alberta schools b) ensure Alberta schools receive operations and maintenance funding that considers building needs and allows for efficient, ongoing maintenance of schools into the future c) center the needs of students ensuring they have equitable access to safe and healthy schools that are well maintained d) remove utilization rates as a factor in operation and maintenance funding

That the Minister of Education engage key stakeholders in the education system in the policy review including school boards, school councils, and teachers.

That the Minister of Education work with the municipal level of government to coordinate planning and ensure that building new and maintaining old schools are considered as communities grow and change.

4. That the Minister of Education provide a full and public explanation for the decisions to de-fund ASCA and to create the Minister's Parent Advisory Group.

That the Minister of Education initiate a full and broad consultation into the decision to de-fund ASCA. That the Minister of Education reconsider the function of the Minister's Parent Advisory Council.

That the Minister of Education validate the important role of ASCA in supporting school councils by reinstating reasonable funding.


## **Heritage Celebration Committee**

Dear Mr. Chu, Ms. Borthwick, and Ms. Rasool:

The Alberta School Councils' Association (ASCA) Board of Directors met on June 26 and 27, 2021 for a regular Board Meeting, during which I was directed to communicate to you ASCA's concerns related to the use of the ASCA Register of Members provided to you, and the subsequent letters sent to ASCA Member School Councils containing inaccurate and misleading information calling into question ASCA's integrity.

While acknowledging the expediency with which you responded in April to the concerns expressed to you by our Executive Director, and the haste with which you issued a corrective statement and apology, the ASCA Board remains concerned about the potential long-term impacts on the Association of the original actions undertaken.

By using the ASCA Register of Members in a manner not originally stated in your request for the Register, and by directly contacting ASCA Member School Councils represented at the 2020 ASCA Regular General Meeting (RGM) calling into question aspects of their rightful participation at that RGM, the ASCA Board has determined that the FFCA NWE School Council and the FFCA SWE School Council acted in a manner deemed detrimental to the Association.

The ASCA Board does not wish to pursue punitive actions available to it as stated in ASCA Bylaws 4.7, 4.8 and 4.9. <a href="https://www.albertaschoolcouncils.ca/public/download/files/40772">https://www.albertaschoolcouncils.ca/public/download/files/40772</a>

The ASCA Board prefers to continue to build a positive relationship with FFCA NWE and SWE School Councils. To do so, the Board requires, in writing, evidence that the Register of Members, which it is understood was widely distributed at a provincial meeting of Charter School representatives, will be destroyed, or will be requested to be destroyed by those in possession of it. Future use of the Register of Members provided to you in November 2020 is expressly prohibited.

The ASCA Board also requires, in writing, an acknowledgement from both school councils that any further actions using the Register of Members, or any further communications with ASCA Member School Councils calling into question aspects of their rightful participation at any

General Meeting of ASCA, may result in the ASCA Board calling a Special Meeting of the Board to consider suspension of, or expulsion from, ASCA Membership.

I sincerely hope this letter will help FFCA NWE and FFCA SWE School Councils to understand the severity of their actions, and that a sincere desire to rebuild a fractured relationship will be forthcoming.

Foundations for the Future Charter Academy (FFCA) Northwest Elementary and Southwest Elementary School Councils received your letter regarding ASCA's concerns related to the use of the ASCA Register of Members provided to Northwest Elementary and the subsequent letters sent to various member schools.

While use of the Register is governed by Section 36.1 of the *Societies Act*, our Councils prefer to continue building a positive relationship with ASCA. We can confirm that the Register of Members provided in November 2020 has been destroyed by those in possession of it as requested, and was not widely distributed.

We acknowledge that the ASCA Board may call a Special Meeting of the Board to consider suspension of (for not more than three consecutive months) or expulsion from (for the duration of the membership term) ASCA Membership, under Bylaws 4.7 and 4.8, for actions deemed detrimental to the Association.

We recognize that the decision of the Board at a Special Meeting convened to consider the suspension or expulsion of a member is final under Bylaw 4.9, but all other matters of dispute are subject to Section 22 of the Societies Act.

We look forward to continuing to build a strong relationship with ASCA where Charter schools are viewed as a respected and valuable educational partner.
